## Instructions for use of this form

This form must be completed AND fully endorsed in the appropriate areas. Complete application packages for an exchange student must be sent directly to the University of Alberta exchange administrator responsible for administering the exchange.

Exchange applications with incomplete forms or missing documents will experience delays in processing. Completed exchange applications require approximately 6-8 weeks to process for admission at the University of Alberta.

## A complete Exchange Student Application MUST INCLUDE:

- 1. A completed Faculty of Graduate Studies and Research Application for Visiting Graduate Students form.
- 2. An official record of all post-secondary work completed and/or presently being taken by the student. Official records must contain an official seal or signature.
- 3. Documentation to demonstrate English Language Proficiency as stipulated in the Exchange Agreement.
- 4. A completed Incoming Graduate Exchange Student Permission to Participate Form.
- 5. A photocopy of the personal information page on the passport.
