Course Description and Objectives:

The main objective of this course is to familiarize students with the process of translation and theoretical issues associated with it. In all aspects of the course, emphasis will be placed on the integration of theory and practice. The notion of equivalence will be studied at different linguistic levels, from lexical to pragmatic, and practical exercises will reinforce what is learned from lectures, readings and presentations by guest lecturers, whenever possible. The language of instruction and the source language for all exercises and assignments is English. Students' programmes and interests may determine source language for assignments. Students will participate in group discussions and presentations, so it is imperative that they come to class prepared to discuss assigned readings and weekly assignments.

Grade Distribution:

Course requirements consist of the following:

- class presentations, participation, in-class exercises and homework	20%

Please note: The "take home" assignments must be approx. 2000 words long, and must include:

- the main body of the text (typed, double spaced, margins: one inch on all four sides). Diagrams, if relevant, may also be included.
- <u>bibliography</u> (bibliographic references should follow one of the standard guides, e.g., Blakey & Cook The Writing of Term Papers).
- <u>footnotes</u> (number the footnotes serially throughout the essay and type them on a separate sheet).

At the beginning of the essay students should identify the aim of the paper, and describe the methods and data to be used. Brief references to other studies on the topic are in order. Formulation of working hypotheses and/or basic assumptions should be presented. In the conclusion the author must verify the hypotheses and/or provide a summary of his/her findings.

Students unable to hand in assignments on time must contact the instructor for an extension at least two days prior to the due date. Extensions will only be granted in unusual circumstances. Lack of time and assignments due in other courses do not constitute valid excuses. Failure to request an extension will result in a deduction of 5% per day past the due date.

In this course

Attendance will be taken at every class meeting. Students are required to attend classes regularly. They should arrive prepared and on time. Many evaluation procedures will take place during regular class time and cannot be made up, except under exceptional circumstances. **Late arrival in class:** Inasmuch as the

beginning of each class is extremely important, it is mandatory that students arrive in class on time. In the case of a 10 minutes tardiness (or less), attendance will be credited. Beyond the first ten minutes, tardiness will be treated as an absence.

Unexcused absences will affect the student's grade. In this course regular attendance is imperative, therefore students who miss more than five days of classes will seriously undermine their performance.

Policy for Late Assignments:

Late assignments, including writing quizzes, will be allowed only in cases with valid reasons. Students who consult in advance with an instructor regarding contingencies that prevent the timely completion of an assignment may be granted an extension at the discretion of the instructor. Otherwise, assignments may be handed in one class-day after the stated deadline without penalty, with a 5%-per-class-day penalty assessed for each subsequent class-day of lateness.
