## COURSE DESCRIPTION AND OBJECTIVES:

A continuation of SPAN 111. Prerequisite: SPAN 111 or consent of Department. Note: not to be taken by students with native or near native proficiency, or with Spanish 30 or its equivalents in Canada and other countries.

Students should be aware that this is a rigorous course aimed at those students who wish to attain a working knowledge of Spanish, and the objective conditions will be created whereby all students can have a successful learning experience. Students will:

- develop basic communicative skills
- be able to understand others and express themselves in spoken and written Spanish
- use Spanish to communicate in a wide range of contexts
- interact with Spanish texts on a variety of subjects
- attain an increased awareness of and cultural sensitivity to the Spanish language
- gain knowledge of some social and historical aspects of the Spanish-speaking world

# **EXPLANATORY NOTES ON ASSIGNMENTS:**

Tasks

#### 35%

Each unit entails the completion of one or more tasks, which may consist of written assignments or oral presentations to be done individually or in group. Some of these tasks will have a grade assigned to them. The total weight of the tasks is 35% of the total grade of the course, but each individual task will not weight more than 10% of the total grade of the course. Specific details about the tasks and due dates will be discussed in class.

#### Language skills test

There will be one test in which your listening, reading and writing skills will be assessed. This test will take place on <u>October 15</u>. Further details about this test will be discussed in class.

#### Grammar and vocabulary tests

There will be two tests (each worth 10%) in which the grammar and vocabulary worked on in class will be assessed. The dates for these tests are <u>October 5 and November 16</u>. Further details about these tests will be discussed in class.

### Oral exam

Students will be required to participate in an oral exam designed to assess students' communicative competence in the language. The oral exam may be in the format of a <u>short conversation</u> or an <u>oral presentation</u>, and will be done <u>in pairs or small groups</u>. The oral exam will take place on <u>December 1</u> (Note: oral exams will take place on December 2 as well if more time is needed). Further details about the oral exam will be discussed in class.

#### Final exam

The final exam will be divided into a language skills part and a grammar and vocabulary part, to be written on <u>December 3 and 7</u>, respectively. Both parts together constitute 25% of the grade for the course. No dictionary or other material or electronic devices will be permitted during the exam. Further details regarding content and format will be discussed in class.

#### **GRADING**:

Marks for assignments, tests, and exams are given in percentages, to which letter grades are also assigned, according to the table below ("MLCS Undergraduate Grading Scale"). The percentage mark resulting from the entire term work and examination then produces the final letter grade for the course.

  Please, note that a "Statutory Declaration" submitted at the end of term covering multiple absences during the term will not be accepted.
- A student must inform the instructor within two working days following the class which was missed, or as soon as the student is able, having regard to the circumstances underlying the absence.
- For missed exams or term work, no extension will be given after this deadline has elapsed and a grade of ZERO will be assigned.
- For an excused absence where the cause is religious belief, a student must contact the instructor(s) within two weeks of the start of Fall or Winter classes; and within three days of the start of Spring or Summer classes.

- No request for make-up for missed work or exams will be considered without proper documentation.
- Providing any kind of document(s) does not imply an automatic approval; it will be at the discretion of the instructor to accept or decline a document and/or grant the student's request for an excused absence.

**b.** Unexcused absences. Each student is allowed <u>four unexcused</u> absences for the entire term. This does not include days on which assignments are due or when an exam or test is given. For any unexcused absence beyond the allotted four, 2% per unexcused absence will be taken off the final course grade. In addition, a grade of ZERO will be given for any exams, quizzes, assignments or participation grade sheets that are not handed in or completed as a result of an unexcused absence.

- Students should be aware that **under** <u>no circumstances</u> will homework assignments, quizzes, compositions, and/or written and/or oral exams/presentations be made up unless special arrangements have been made with the instructor <u>prior</u> to the due date or the exam date.

- Students with credit in SPAN 100, or with Spanish 30 or its equivalent in Canada and other countries.
