COURSE DESCRIPTION AND OBJECTIVES:

Intended to further develop knowledge of spoken and written Spanish with a focus on intercultural communicative competence. Prerequisite: Spanish 30 (or equivalent) or SPAN 112 or consent of Department. Note: not to be taken by students with advanced standing equivalent or near native ability.

SPAN 211 is an intermediate course designed to build on basic knowledge and skills. We will review in depth some of the more difficult grammatical structures and further develop skills in reading, writing, listening, and speaking Spanish. We will also attain a deeper awareness of some of the social and cultural aspects of the Spanish-speaking world. By the end of the course, you should be able to communicate more effectively in both oral and written Spanish.

Each unit entails the completion of one or more tasks, which may consist of written assignments or oral presentations to be done individually or in group. Some of these tasks will have a grade assigned to them. The total weight of the tasks is 40% of the total grade of the course, but each individual task will not weight more than 10% of the total grade of the course. Specific details about the tasks and due dates will be discussed in class.

Language skills tests

There will be two tests, each worth 10%, in which your listening, reading and writing skills will be assessed. These tests will take place on <u>October 15 and December 3</u>. Further details about this test will be discussed in class.

Grammar and vocabulary tests

There will be three tests (each worth 10%) in which the grammar and vocabulary worked on in class will be assessed. The dates for these tests are <u>September 29</u>, <u>October 27</u>, and <u>December 3</u>. Further details about these tests will be discussed in class.

Oral exam

Students will be required to participate in an oral exam designed to assess students' communicative competence in the language. The oral exam may be in the format of a <u>short conversation</u> or an <u>oral presentation</u>, and will be done <u>in pairs or small groups</u>. The oral exam will take place on <u>December 1</u>. Further details about the oral exam will be discussed in class.

GRADING:

Marks for assignments, tests, and exams are given in percentages, to which letter grades are also assigned, according to the table below (**"MLCS Undergraduate Grading Scale"**). The percentage mark resulting from the entire term work and examination then produces the final letter grade for the course.

a.  Please, note that a "Statutory Declaration" submitted at the end of term covering multiple absences during the term will not be accepted.
- A student must inform the instructor within two working days following the class which was missed, or as soon as the student is able, having regard to the circumstances underlying the absence.
- For missed exams or term work, no extension will be given after this deadline has elapsed and a grade of ZERO will be assigned.
- For an excused absence where the cause is religious belief, a student must contact the instructor(s) within two weeks of the start of Fall or Winter classes; and within three days of the start of Spring or Summer classes.
- No request for make-up for missed work or exams will be considered without proper documentation.
- Providing any kind of document(s) does not imply an automatic approval; it will be at the discretion of the instructor to accept or decline a document and/or grant the student's request for an excused absence.

b. Unexcused absences. Each student is allowed <u>two unexcused</u> absences for the entire term. This does not include days on which assignments are due or when an exam or test is given. In addition, a grade of ZERO will be given for any exams, quizzes, assignments or participation grade sheets that are not handed in or completed as a result of an unexcused absence.
