Course Description, Objectives and Expected Learning Outcomes:

In this course, students will explore various cultural products that make use of mystery (and myth and supernatural elements) in order to understand how culture is influenced by, and influences them. The instructor will first focus mainly on the media "bande dessinée" and one of its genre, the detective story. Students will then be able to choose one francophone "story" (as a book, film, video games, ...) that they like and present it to the class. Material will be learned through reading, writing, viewing, listening and thinking!

Objectives are: learning as much as possible about modern and contemporary France and Francophone countries, and specifically French culture and politics. By the end of this course, successful students will be familiar with main issues (political, ethnic, gender, institutional, cultural) in France and Francophone countries and regions, able to discuss and analyze them as well as write cogently about them in French.

Texts:

All required (all textbooks are on reserve at Rutherford Library, but be careful because there is only one copy and you are over 20 in this class; they also can be bought at the campus bookstore; students can buy half of the textbooks with an other student and share the other half with her/him).

Explanatory Notes on Assignments:

Oral presentations: Students will be able to choose one francophone "story" (as a text, film, videogames, ...) and present it to the class. The length of the presentation is about 10-15 minutes. Students will have to use a visual aid such as PPT with useful pictures and bullet-type short sentences.

Midterms: Questions will be on all the material seen in class; there will be 15 questions each requiring a short-paragraph answer.

Final project

Students will have the choice between

- -writing an essay of 10 pages (TNR 12 double space) = 30%
- -or a CSL project where 15% will be the CSL project itself and 15% a 5 page (TNR 12 double space) essay on the CSL experience (to be explained more thoroughly in class) -or a creative project made of 2 parts: 5 pages drawn adapted from a short detective story (15%) accompanied by a short essay (TNR 12 double space) explaining the creative project (15%).
