**Course Description, Objectives and Expected Learning Outcomes:**

This course focuses on mythology, the supernatural, and superstition as cultural and literary phenomena in the French-speaking world. Through these overarching themes, it offers an introduction to past and current artistic and literary trends that characterize French and/or francophone societies. The course will be given entirely in French. At the end of this course, students will have acquired a basic knowledge of representative works pertaining to mythological and supernatural themes in French literatures, as well as in some exemplary cinema and/or media; they will also have acquired intermediate-to-advanced skills in written argumentation in French, as well as consolidated their previous knowledge of the language, both oral and written.

**Course Format:** The objectives of this course will be learned from a combination of short formal lectures, assigned readings, and audiovisual material.

**Explanatory Notes on Assignments:**

The two written assignments will have students write a short (500 words) critical piece on 1) a movie, and 2) a literary text chosen among the ones made available by the instructor on eClass.

The team orals will be conducted in teams of five (5), and will be delivered online to the instructor and the other students. The orals will focus on a movie, a literary work, or a graphic novel chosen by each team (and approved by the instructor). Online workshops will be scheduled for students to interact and prepare their orals together.
