Course Description, Objectives and Expected Learning Outcomes:

Examination of theoretical, sociological and historical aspects pertaining to the contemporary Québécois novel, short story, and film. The course will be given entirely in French. At the end of this course, students will have acquired a basic knowledge of representative works pertaining to francophone Québec culture and literature in the genres of poetry and novel, as well as in some exemplary cinema; they will also have acquired advanced skills in oral debating in French, as well as consolidated their previous knowledge of the language, both oral and written.

Course Format: The objectives of this course will be learned from a combination of short formal lectures, assigned readings, and audiovisual material.

Texts: List of 5 required books will be available on eClass on August 27.

Critical review of one of the assigned books (20%) --- due October 14

Club de lecture (30%) --- 5 % every two weeks / begins on Monday August 14

Journal de lecture (20%) --- final version due December 9

Final Exam (30%) --- December 15

Explanatory Notes on Assignments:

The critical review will be a short written assignment (500 words) on one of the assigned literary works selected by the student.

The “club de lecture” (book club) will happen online every two weeks and will take the form of a guided discussion with the instructor and all other participating students.

The “journal de lecture” (reading log) will require students to document their own reading experience with each assigned books. The final version of the journal will be handed over to the instructor and will get a mark at the end of the semester.
