### **Course Description and Objectives:**

SPAN 306 is an intermediate course designed for speakers with an advanced level of oral proficiency, but

no previous formal study of Spanish. Focus is on topics such as grammar and sentence structure, spelling and punctuation, interference between English and Spanish, and colloquial versus formal usages with the objective of improving skills in oral and written communication.

## Learning outcomes:

At the end of this course, successful students will be able to:

- Discuss and appraise cultural aspects of Spanish-speaking countries
- Use appropriate vocabulary, grammar and spelling in their written texts
- Use appropriate vocabulary and grammar in oral presentations
- Organize their ideas into a coherent written text
- Recognize formal and informal uses of language

**Course Format:** The objectives of this course will be learned from a combination of formal lectures, assigned readings and audiovisual materials.

# **Explanatory Notes on Assignments and Tests:**

<u>Compositions</u>: You will be asked to write three compositions in class based on topics provided by the instructor. You must indicate the **number of words** at the end of each assignment. Further details will be discussed in class.

<u>In-class or at-home assignments</u>: Throughout the term, you will be given short assignments to complete either in class or at home, as deemed appropriate by the instructor, in order to help you build on your knowledge and practice expressing yourself in Spanish. These assignments may involve any of the four language skills (reading, writing, listening, speaking). At-home assignments will be assigned in class, and a specific due date given. In-class assignments will be announced at least one class beforehand so you can prepare any necessary material (e.g. reading a text). **You are responsible for finding out whether or not an assignment has been given;** not knowing because you were not in class is not an acceptable excuse, as regular attendance is expected.

These assignments will be **ungraded**, but you will receive credit for having completed the assignment. The mark for this component will be the number of assignments you completed (e.g. 18 of 20 assignments completed = 90% = 9/10). Where applicable, the answers will be provided for self-correction. For other assignments where no answer key is possible, the instructor will give you feedback, but no mark will be assigned.

If you miss an assignment due to an excusable absence, you will be excused from that particular assignment, and your grade will be adjusted accordingly. For an unexcusable absence, or if you simply forgot, you will not receive credit for the assignment.

<u>Tests</u>: There will be three tests throughout the term. The tests will include **all the material discussed in class in relation to the chapters covered up until the date of the test**, including any material distributed by the instructor in class or posted on eClass. You are responsible for ensuring that you have all the necessary material. No dictionary or other material or electronic devices will be permitted during the test.

Oral presentation: You will have to prepare a short presentation about a Spanish-speaking country.

The presentation must be in digital format (e.g., PowerPoint), and you will have to present it to the rest of the class. Further details will be discussed in class.

<u>Group projects:</u> These are theme-related projects to be done in groups of two. Examples of these projects include creating promotional posters and brochures, magazine ads, websites, etc. Specific details about the projects and due dates will be discussed in class.

# Participation and attendance:

Regular daily attendance and active participation in class are essential for optimal performance in a language course. This is also true for the remote environment for this fall term. For Spanish 306, this means we will meet Mondays, Tuesdays, and Thursdays via Zoom video conferencing. During the video conferencing sessions, you are expected to participate just like in a regular classroom, e.g. interact with your classmates and the instructor in Spanish with a microphone so that everyone can hear you and a camera turned on (because nobody wants to talk to a black screen). In-class participation includes not only evidence of individual preparation and attention, but also contributing to group work.

You are also expected to attend class regularly and punctually. Attendance will be recorded on a daily basis. If you miss a class, it is your responsibility to make up work and learn the missed material. Students are encouraged to communicate with other students (or with the instructor by email or in office hours) to keep up with missed classes. Do not expect your instructor to go over material in class again because you were absent. Please be aware that unexcused absences will negatively impact your participation grade (see notes on attendance below). The instructor expects students to have read and completed the relevant materials before coming to class.

<u>Note</u>: If persistent technological problems with internet connections arise during the term, the instructor may decide (in consultation with the coordinator) that all students will be evaluated without the participation component. Thus, students will not have to turn their camera on at all times.

- <u>a. Excused absences</u> are not automatic; therefore, in cases of potentially excusable absences (emergency conditions, incapacitating illness, religious convictions or legitimate University-related business), students may apply for an excused absence for missed classes, term work, or exams. Please note:
- For an absence to be considered excused, instructors will request adequate documentation to substantiate the reason for the absence (i.e. in the form of a "Medical Declaration Form for Students" <a href="https://uofa.ualberta.ca/arts/-/media/arts/student-services/documents/medicaldeclarationformforstudents.pdf">https://uofa.ualberta.ca/arts/-/media/arts/student-services/documents/medicaldeclarationformforstudents.pdf</a>). Please, note that a "Statutory Declaration" submitted at the end of term covering multiple absences during the term will not be accepted.
- A student must inform the instructor within two working days following the class which was missed, or as soon as the student is able, having regard to the circumstances underlying the absence.
- For missed exams or term work, no extension will be given after this deadline has elapsed and a grade of ZERO will be assigned.

<u>b. Unexcused absences.</u> Each student is allowed <u>three unexcused</u> absences for the entire term. This does not include days on which assignments are due or when an exam or test is given. For any unexcused absence beyond the allotted three, one point out of the five total points will be deducted from the student's <u>participation and attendance grade</u>. In addition, a <u>grade of ZERO</u> will be given for any exams, quizzes, or assignments that are not handed in or completed as a result of an unexcused absence.

- Students should be aware that under <u>no circumstances</u> will homework assignments, quizzes, compositions, and/or written and/or oral exams/presentations be made up unless special arrangements have been made with the instructor prior to the due date or the exam date.
