Course Description and Objectives:

Russian 304 is a continuation of Russian 303 and meets three hours per week (Mon, Wed, Fri). The goals of this course are: to further improve Russian grammar; to broaden this foundation with the addition of advanced grammar and syntax; to increase vocabulary; to further develop speaking, understanding, reading and writing skills. Special attention will be paid to listening and comprehension skills. In order to achieve these goals, students will work with materials from Russian news clips, songs and films. Listening exercises will also be included in homework assignments. As students develop their fluency and vocabulary, they will gain deeper insight into Russian culture, discussing topics such as history, music, cinema, art, current affairs, and television in Russian.

By the end of the course, successful students will be able to express themselves more effectively and more accurately in Russian with a greatly expanded vocabulary, read and critically discuss various types of texts, analyze short stories, prepare oral presentations, and be more aware of the differences and similarities between the cultures of the Russian-speaking countries and North-American cultures.
