# **Course Description and Objectives:**

Literature is a vehicle by which readers are transported into realities very different from anything they have known. Through of a selection of some of Latin America's most celebrated texts, this course will broaden students' knowledge and understanding of the continent by exposing them to a wide variety of human experiences in diverse social, political, and cultural contexts. More specifically, the course aims to provide: i) a historical overview of Latin America's rich intellectual history through the study of its literary genres, periods, and movements, and ii) a fertile environment for the development of linguistic proficiency. By the end of the course students will notice a marked improvement in their writing, aural and written comprehension skills, and they will be able to recognize and think analytically about a variety of foundational texts from very diverse contexts.

Required: *Letras de Hispanoamérica*, by J. Ortega, G. Pellón, and M. Gaspar (available in U of A bookstore).

# **Reading Assignments**

These assignments are guided reading tasks intended to encourage a focused and productive reading of the prose materials studied in class. One of these assignments is to be written up in essay format. In the document "Tareas de Lectura" in e-class you will find a list of the eligible texts, requirement specifications, and grading criteria. Assignments are due the first day in which the selected work is taken in class. Two of the texts must be from before the Mid-Term, and two after. See e-class daily schedule for dates. All assignments must provide a cover page, and are to be double spaced and stapled; only hard copies will be accepted

# **Class Participation**

Attendance to class is not included in the class participation component of the grade. Only active, positive, and consistent contributions to class discussions will count. Therefore students are encouraged to take notes on the readings and come prepared to share ideas and insights. A good way to prepare for class is by answering the questions at the end of the selections. Disruptive or disrespectful behavior (e.g. constant whispering while instructor is talking) will lead to a reduction in the class participation grade.

# **Policy for Late Assignments**

The penalty for late assignments is 1 mark per day. Students who consult in advance with an instructor regarding contingencies preventing the timely completion of an assignment may, at the discretion of the instructor, be granted an extension just one time throughout the course, with no penalty. However, if a second excuse is accepted, that assignment will be only be eligible to receive half of the grade. If a Mid-Term or Quiz is missed due to extenuating circumstances (e.g., illness), the weight of that assignment could, at the discretion of the instructor, be transferred to the final exam.
