Course Description and Objectives:

In this course, students will discover various varieties of spoken French as well as improve and perfect their pronunciation of Modern Standard French. To that end, students will learn the articulatory features of speech production and ways in which to correct and enhance their oral production. At the end of the course, students will be able to identify their own difficulties, to use strategies to correct them, to assess their own progress, and to define their own plans for further improvement.

Explanatory Notes on Assignments (more explanation available on eClass):

- Assignments: Each assignment consists in the recording of various texts that contain the specific phonetic features worked on.
- Class presentation: Students will choose a part of the world where French is widely spoken and present the characteristics of the variety of French spoken there.
- Personal Progress Dossier: Students will track their personal difficulties (those worked on in class and at least one other), the strategies they have used to improve on them, and their progress. (2-3 pages)
- Oral Exam: Presentation of the personal progress dossier; practical demonstration of the progress made followed by a self-evaluation.
