Course Description, Objectives and Expected Learning Outcomes:

This course will teach basic critical tools for textual analysis and essay writing as well as assist students in developing their own reading and writing strategies. Students will learn to perform close readings of modern French literary texts using the concepts and methods discussed in class. Many questions will be debated concerning literature and the cultural values associated with it. Attendance is extremely important as lectures, discussions and reading/writing exercises will provide the "nuts and bolts" for the course. Enough time will be allotted for students to read the texts before discussing them

in class and it is essential that they come fully prepared to discuss assigned daily portions having researched vocabulary and concepts as well as thought about assigned questions.

At the end of the course students will be able to discuss cogently issues of French literature and culture, such as genre, style and narrative strategies, as well as write wellstructured essays that formulate well-researched and convincing arguments.

Course Format: The objectives of this course will be reached through a combination of formal lectures, group work, assigned readings and audiovisual materials.

There will be 3 topic choices for Essays that will progressively be longer (1500 words; 2000 words; 2500 words)

Responses to readings will be assigned on a weekly basis to individuals or pairs.

Participation: You are expected to attend and actively participate in class. This includes thoroughly preparing all work assigned for each class session and contributing actively to class discussion and activities. This includes not only regularly sharing your own thoughts about what we read but also listening attentively and responding to classmates' ideas.

The final exam will be a combination of knowledge questions and a short essay on a topic chosen from 3 possible themes.
