Course Description, Objectives and Expected Learning Outcomes:

This course focuses on 20th and 21st century autobiographical writing in French. Six novella length autobiographies form the core of discussions relating to the various forms of first-person writing that have become very popular since the 1960s: “ordinary” autobiography, auto-fiction, journals and diaries, letters, and blogs. We will examine the history of first-person life writing and consider prevalent themes and critical approaches to studying the variety of forms to approach autobiography in its contemporary forms.

At the conclusion of the course students should be able to handle the critical terminology used

in contemporary autobiography, be able to analyze first-person narratives as a critical reader, and have compiled a list of important 20th and 21st century writers who have contributed significantly to the genre.

Course Format:

This course includes extensive reading and class discussion as well as film and other online resources. A combination of lecture/seminar-type discussion/small-group discussion provides a variety of approaches to the learning outcomes.

Grade Distribution and Explanatory Notes:

Participation 10%

Participation includes regular attendance as well as regular participation in class discussion.

Midterm 1 20% (30 Jan 2020)

This midterm will focus on short essays, terminology definitions, and critical questions important for the study of autobiographical writing.

Midterm 2 25% (25 Feb 2020)

This second midterm will involve (a) a take-home essay and (b) an in-class analysis of a passage selected from a reading discussed during class.

Table ronde 15% (24 and 26 Mar 2020)

The round table will give each student the opportunity to outline and discuss the chosen subject for the final paper in the course. All members of the class will be able to ask questions and

provide suggestions.

Final Paper 30% (8 Apr 2020)

Each student will choose their own topic for the final paper in consultation with the instructor. The final paper will be 16-20 pages in length and include appropriate bibliography.
