Course Description, Objectives and Expected Learning Outcomes:

The course is based on blended learning concept – students study the content of lessons at home and do exercises using zoom platform.

The main goal of the course is to train the student to use the Polish language in everyday situations. The principles of applied linguistics will help to utilize the grammar and to hold a basic conversation in Polish on a wide array of topics, e.g. personal life, studying, partying, sports, shopping, hobbies, health, travel, and many more topics related to everyday situations. At the end of the course, the student will be able to demonstrate a solid competence in basic standard Polish, having developed good reading skills and oral competence. Grammar explanations will be conducted in both English and Polish. All other conversation will be conducted in Polish, sometimes with the help of contrastive analysis of both languages

In this Course

In this course regular attendance is imperative, therefore students who miss more than five days of classes will seriously undermine their performance.
